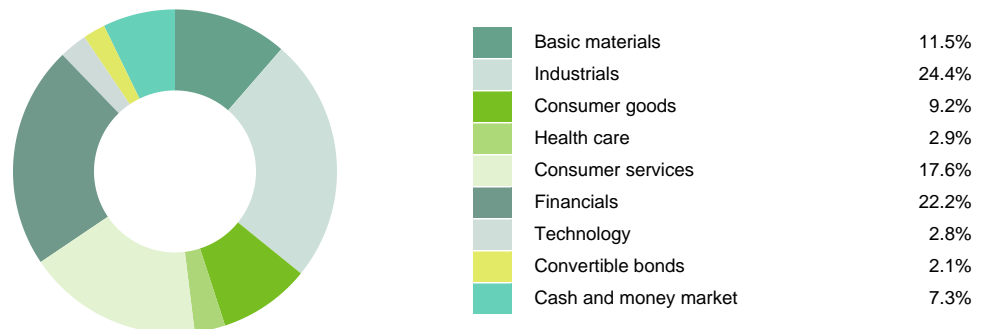

- A domestic equity fund targeting maximum capital appreciation over the long term.

- Permitted to hold up to 20% large cap stocks if purchased prior to their Large Cap Index migration.
- Composed mainly of growth stocks due to affinity for businesses with enduring competitive advantage.
- Due to its concentrated nature, the portfolio may be volatile relative to diversified category peers.
