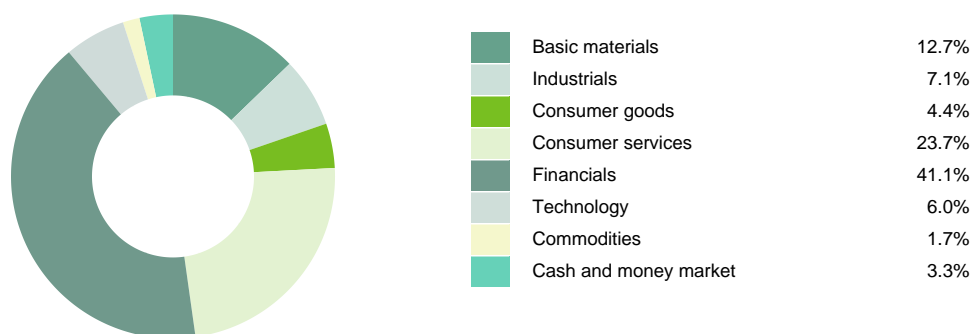

- A concentrated fund holding approximately 30-35 shares listed on the South African equity market.
- The fund is industry and size agnostic, providing some exposure to small and mid-sized companies.
- Highly active approach to fund management, derived from a valuation-based investment approach.
- Proprietary research generated by a team of equity specialists.
- The benchmark is used in portfolio construction primarily as a final risk management tool.
